As we begin to hear reports of the damage sustained by our NYSUT brothers and sisters, please find some resources and points of contact that we can provide to those calling for assistance or are looking to help out:

RESOURCES:

<u>United Way 2-1-1:</u> For those members who need assistance with basic needs, we refer them to the United Way's 2-1-1 hotline which is operational in most of the affected areas. Further information regarding United Way's 2-1-1 program and disaster guide can be found at <u>www.211ny.org</u> or <u>www.uwnys.org.</u>

<u>FEMA:</u> If you haven't contacted the Federal Emergency Management Agency yet, call (800) 621-3362 or if you are able to access the Internet, go to <u>www.disasterassistance.gov</u>. If you are calling be aware you will need to have: your Social Security number, current and pre-disaster address, telephone number where you can be reached; insurance information, including policy numbers; total household annual income, a description of losses caused by the disaster; and the dates of the disaster. In New York, the following counties have been declared as disaster areas: Bronx County, Kings County, Nassau County, New York County, Queens County, Richmond County and Suffolk County.

<u>U.S. Department of Labor:</u> The U.S. Department of Labor is assisting in the recovery efforts in communities affected by this season's hurricanes and their relief efforts are summarized at: http://www.dol.gov/opa/hurricane-recovery.htm

<u>AFT PLUS Member Benefits:</u> Union Privilege offers up to \$500 in grants for union members hurt by natural disasters, provided they meet two requirements: 1) Members who have an AFT credit card or mortgage in place for 12 months prior to the disaster, and 2) FEMA declares their county of residence a disaster area. If both of these terms are met, AFT members are eligible for a grant of up to \$500.
