NO on convention

In November, the referendum on whether or not New York State should have a Constitutional Convention will be on the ballot. RETIREES HAVE A PARTICULARLY GOOD REASON FOR RESISTING SUCH A CONVENTION: the protection the current constitution has against the diminution of our pensions, which has been upheld by the courts and has protected our funds on several occasions over the vears.

There are other reasons to vote no. It is estimated that a constitutional convention will cost over \$50 million. That money would be better spent on a pension COLA,

public education or higher education.

And there is no limit to the range of issues that may be brought before such a convention: cuts in school programs, public aid to private schools, vouchers, changes in environmental protections, elimination of workers rights to organize and to collective bargaining, as well as health issues.

If the constitution needs amending, it can be done through the legislative process. Constitutional amendments may be proposed in the senate and assembly, and if such amendments pass two successive legislative votes, they go before the voters for

RETHINKING THE MEANING OF LABOR DAY

Recently, through the e-mail, I received a thought-provoking article written by J. Federico Martin, President of AFSCME Clerical Local 3235 at UCLA. In light of the recent UPS strike, down-sizing, and part-time employment practices, I was very moved by his words and felt I would like to share these thoughts with you. They are as relevant to us as retirees as they are to in-service workers. I would welcome responses and reactions from you.

"When in Shakespeare's 'Julius Caesar' it is said that the 'evil that men do lives after them', it speaks of the lasting and abiding effects of malevolent human acts on fellow human beings. In the twentieth century the Jewish Holocaust symbolizes the Great Evil that remains a red spot on humanities'

hands.

But there are lesser evils that quietly happen every day. Acts against people that can only be described as 'evil' because of the absence of conscience. Acts that unfortunately are too often overlooked because they occur individually and in the workplace. ... But because the infliction is emotional and psychological, the wound is invisible. And so too the act. ... No one sees this daily violence.

There are no newspaper headlines, no TV or radio broadcasts, no public opinion, no condemnation. Labor laws are woefully inadequate. The government no longer protects its people. Even workers have failed to protect themselves by not rising up on their own behalf. And by not helping each other

they have made each other vulnerable to employer abuse.

I believe that we must restore morality to the workplace. To restore a sense of right and wrong upon which we act. ... In these times of change and upheaval, times in which we have seemed to lose direction, we need to reassert those basic, fundamental principles of conduct to guide us, and against which to hold those in power accountable.

... Those of us in the union ... struggle against employment practices that dehumanize us all. We believe that we should not lose our humanity as a condition of our employment. Nor our self-esteem. We should not live in fear of those who employ us and exercise abusive authority. There needs to be a balance against power held over us, so that we do not become things to be manipulated or thrown away.

... A union is a reminder to the employer of our humanity. And a demand for respect and dignity. It lies at the heart of the concept of unionism, and

affects the very quality of our lives.

These days, when the 'bottom line' has replaced moral conscience, we

need to reassert - not yield - our humanity."

NAFTA: 3 years later

ore than three years have elapsed since the North American Free Trade Agreement (NAFTA) went into effect, but the treaty hasn't produced the benefits that its supporters promised. reports the AFL-CIO

Mexican workers' wages have remained stagnant, and as many as 700,000 good-paying American jobs have been lost, the union reports. adding that human rights abuses in Mexico have become worse, not better. The job losses have been concentrated in industries like apparel, auto parts and electronics, hurting low-paid workers with few skills the most.

In fact, NAFTA increased incentives for firms to bargain down wages and working conditions in the U.S., Canada and Mexico, and to shift jobs to Mexico, according to the Institute for Policy Studies.

The Institute's new report, NAFTA's Corporate Camouflage, reveals that six of the leading corporate NAFTA advocates used the threat of moving plants abroad to head off union organizing drives, and 12 of 28manufacturers laid off workers who then qualified for the NAFTA retraining program. The story behind downsizing

With corporations laying off workers and flattening their management, what's the real story behind this recent trend?

The American Management Association (AMA) reports that only 6% of the corporations that laid off workers last year said they did it because they were suffering losses or anticipating a business downturn. "Organizational restructuring" was the reason given by 68% of companies the AMA surveyed, which usually means cutting labor costs to hike profits. It also probably explains why 70% of people polled recently by the Preamble Center for Public Policy say corporate greed, not competitiveness, is behind the downsizing.

This may be a case where people's perceptions are correct. Corporate executives' compensation rose 223% in inflation-adjusted terms since 1976, while real wages for American workers moved up only 5%, according to the U.S. Census Bureau.





NEWS NOTES


Chester Shapiro informed us of the death of Jean Weinstein at the end of June. Our thoughts are with husband Gordon, and family.

shopped for, wrapped and delivered gifts and food on Christmas Eve.


