LEGISLATIVE UPDATE- Jack Zuckerman

We have been politically active on your behalf. We have been meeting with the Long Island legislators with some encouraging results. Another article appears in our Newsletter which deals with our latest efforts in Albany.

Remember that when you read of legislation, political action, and other areas vital to our interests that you are a member of ROBS <u>AND</u> you are <u>also</u> a member of the ED 21 Retiree Council. You should receive the *On Track* newsletter from NYSUT. This is our area newsletter. The point here is that political action is organized statewide by NYSUT through VOTE-COPE and, for retirees, through the Retiree Councils. So if you wonder if we are watching out for your interests, you bet we are! You can follow the information in the *New York Teacher* and in *On Track*.

Should the BTA ask us to become active in school budget campaigns and/or school board elections then we would become politically active at the ROBS chapter level. We would function at the local level and our Newsletter would keep you informed of all developments.

RETIREES' LOBBY DAYS

This year, NYSUT sponsored Retiree Lobby Days for five different areas of the state commencing on May 17, 24 and June 7, 14, and 21. Long Island's day was Tuesday, June 7th. Four busses rolled north at A.M., and retirees descended on legislators en masse, carrying their Committee of 100 bags.

The key NYSUT pension Retirement bills that were focused on were:

- .Permanent COLA Legislation
- .Pension Supplementation
- .Safeguarding Retiree's

Health Insurance the With state budget finalized, the legislators are at the point when they will be voting on critical bills, and it seemed to those of us who lobbied that most of elected officials are at least paying lip-service to being in favor of a permanent COLA. In the same breath, however, they are quick to add that financial constraints make it impossible to pass.

And that is where the Supplementation Bill takes on vital importance. Almost all supported this, recognizing the need for those government employees who retired before 1990 to be able to keep up with the rising cost of living.

Brentwood Retirees who participated in the Lobbying Day were: Dot and Jack Zuckerman, Chris Veech, Ivy Rosenthal. June Dawson, Dorothy Schaller, and Frank Saladino.

To write your legislators about the need for a retiree supplementation for all state workers, refer to S-8413, Trunzo in the Senate, and A-11628 Vitaliano, chairman of the Rules Committee in the Assembly. Stress that it is the permanent COLA Bill (S-5903 Nozzolio and A-5833 Weinstein) that should be passed, but that the Supplementation Bill would be acceptable at this time, to help those retirees who are feeling the pinch of rising costs of medical care as well as other necessities.

Cathy's three years of volunteering to care for the terminally ill have given her as much joy as she has given her patients and their families. Her job is varied, and entails making respite time for the caregivers, and reading to, talking with the patient.

Hospice also offers bereavement support for families, and especially for the children through special funding available. Cathy edits the Hospice Newsletter, and through its outreach, donations have increased.

Vinnie Vuolo calls his work with Literacy Volunteers of America "starting an adventure." Unlike teaching, there is the joy of instant feedback because the tutoring is one on one. These students want to be there, so there is no discipline problem. They want, and need, to learn how to be literate.

LVA conducts a six week

volunteers. Two hours a week is the minimum time to spend with your student, and you may tutor at your convenience.

Vinnie says that in Brentwood the need for volunteers is staggering. The teaching program for both reading and ESL sessions is simplified so almost any lay person can handle the material.

You are planting your seeds.


For someday, it may

LEGAL BATTLE VICTORY

The NYS Court of Appeals unanimously rejected arguments from the Medical Society of NY State that the 1990 state law limiting how much doctors can charge over the Medicare rate should be overturned. The Court ordered the Medical Society to pay legal fees. This final disposition of court action against the 1990 Balance Billing Law means that doctors are forbidden to exceed the government-set rate for Medicare services by more than 10% in New York State.

Furthermore, if the long awaited report from the State Office for Aging shows that doctors have not improved their participation rate in accepting Medicare rates with no balance billing by 5%, the overcharge percentage must be lowered to 5% under the provisions of the 1990 law. Congratulations and heartfelt thanks to Assemblyman Paul Harenberg for his sponsorship of this law!
