Teachers Not To Transport Students

Most teachers have received one or many notices stating the position of the Board of Education and Central Administration on the transportation of students by teachers. However, certain valid questions still remain unanswered.

Q. Can I drive a student home, if he misses the bus because of my error or a teacher requests that he stay after?

A. No. Principals will suggest that you do not students school for any reason, unless a note is sent home to the parents


stating the time, the reason, and the request that the parents arrange for the transportation of their child (other than a teacher). general, a parental request that a teacher drive a student home will not constitute sufficient coverage.

Q. Can I drive a student home, if he misses the bus through his own fault?

A. Yes. According to the District, the teacher can drive the student home in this situation. It would be considered an extraordinary circumstance. However, it is suggested that you speak to your building administrator and receive the proper authorization from him verbally each time a student misses the bus.

Q. What if the building administrator has left the building and cannot be contacted?

A. If a memorandum has been out to the staff by the building principal, then follow his guidelines. If no such building policy exists, then it is suggested that you follow Memorandum #17 that was sent to all administrators: "Should there be any question about 'emergencies', the building administrator," [or teacher] may contact Central Administration.

Q. What about field trips? Can we use our own cars to transport students?

A, No.

Q. Can nurse teachers, attendance teachers or psychologists still transport students as they did in the past?

A, Yes. The rules still apply as they did.

Q. I have a club organization that is composed of my students, but it does not meet on school ground. Can I drive the students to these activities?

A. NO.

Q. Isn't this new ruling going to cut down on activities sponsored by the teaching staff?

A. Not necessarily, different planning is required to arrange transportation.

Q. Why is the District revamping their transportation policy?

A. The change was made by the State Education Department requiring school buses and school bus drivers on all planned school transportation.

Q, Is this the final word on the subject?

A. The B.T.A. has requested NYSUT Counsel to make their interpretation. Because of the of the nature area (liability) involved, it is difficult to make concrete rulings that applicable in all situations. Therefore, the final answer may take quite some time.

Until that time, play it safe and don't take any unnecessary chances.
